Hillingdon Council gives notice that it proposes to make these Orders to:

- 1. Install 'at any time' waiting restrictions in sections of roads as set out in the Schedule to this notice below.
- 2. Install blue badge disabled parking bays at the following locations:
 - i) Outside No. 11 Petworth Gardens, Hillingdon
 - ii) Outside No. 34 Stafford Road, Ruislip
 - iii) On Magnolia Street, West Drayton near No. 60 Rowan Road
 - iv) Outside No. 302 Victoria Road, Ruislip
 - v) Outside No. 65 Alandale Drive, Northwood
 - vi) On the corner outside Nos. 21 to 35 Nine Elms Avenue, Cowley (revised location to previous proposals advertised on 18th October 2023)
- 3. Remove the redundant blue badge disabled parking bays at the following locations:
 - i) Opposite No. 6 Rowan Road, West Drayton
 - ii) Outside No. 11 Barlee Crescent, Cowley
 - iii) Outside No. 53 St Christophers Road, Cowley
 - iv) Outside No. 110 Clyfford Road, Ruislip
 - v) Outside No. 44 Rosedale Avenue, Hayes
- 4. Formalise the existing 20mph speed limit on the section of Queens Walk, Ruislip between the junctions with Long Drive and Victoria Road.
- 5. Introduce 'at any time' loading restriction on the existing 'at any time' waiting restrictions near the junction of High Street, Ruislip and Brickwall Lane.

SCHEDULE - PROPOSED 'AT ANY TIME' WAITING RESTRICTIONS

PIELD HEATH ROAD, HILLINGDON – Convert all sections of existing single yellow lines between the junction with Royal Lane and a point 50 west of the junction with Peel Way. HURSTFIELD CRESCENT, HAYES – At the eastern most junction with Balmoral Drive, between the southern kerbline of Balmoral Drive and the start of the footway parking places. EASTCOTE ROAD, RUISLIP – Extend the existing double yellow lines east of Bishop Ramsey Close by an additional 7.3 metres eastwards.

LONG LANE, HILLINGDON – Extend the existing double yellow lines outside No. 142 Long Lane, Hillingdon northeastwards to outside No. 146 Long Lane.


STATEMENT OF REASONS


The proposed installation of waiting and loading restrictions in various roads is intended to remove obstructive parking to assist free flow of traffic and promote road safety. This will particularly assist emergency vehicles, refuse and recycling trucks, delivery vans and other large vehicles. All proposals have been agreed by the Cabinet Member for Property, Highways and Transport.


The proposed disabled parking bays are intended to benefit disabled people by providing parking bays for the sole use of "blue badge" holders. Redundant bays will be removed to provide more parking for residents and their visitors.


The formalisation of the existing speed limit on part of Queens Walk, Ruislip will support the existing traffic calming measures by way of a Traffic Management Order.


























Hurstfield Crescent, Hayes - Proposed 'at any time' waiting restrictions

The Council of the London Borough of Hillingdon, after consulting the Commissioner of Police of the Metropolis in exercise of the powers conferred by Section 6 and 124 of and part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹ as amended by Section 8 and Schedule 5 of the Local Government Act 1985², the Road Traffic Act 1991³ and of all other enabling powers hereby make the following Order:-

- 1. This Order shall come into operation on XXXXXXXXX and may be cited as The Hillingdon (Waiting & Loading Restrictions) Order 2023 (Amendment No. XX) Order 2024.

- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Hillingdon (Waiting & Loading Restrictions) Order 2023⁴ shall have effect as though:
